korea in june 1950 the united states sought to gain web 21 jan 2023 a resolution introduced by gop reps mike waltz and dan crenshaw authorizing military action against mexican drug cartels fueling the deadly fentanyl epidemic sweeping the u s is gaining more cosponsors web 24 jan 2023 the resolution directs the president to use the military to target several mexican cartels by name all of which manufacture opioids using precursors sourced from communist china that they then send across the southern border that has been left open by joe biden s immigration policies web 28 jun 2017 the authorization for use of military force aumf is a congressional resolution that delineates the boundaries within which the us can use military force it limits the scope of the action by clearly defining a purpose for which force is to be used and the manner in which it is to be used web the main operative portion of the resolution reads the president is authorized to use the armed forces of the united states as he determines to be necessary and appropriate in order to 1 defend the national security of the united web the last time congress passed joint resolutions saying that a state of war existed was on june 5 1942 when the us declared war on bulgaria hungary and romania since then the us has used the term authorization to use military force as in the case against iraq in 2003 how a war powers resolution could limit trump in iran web 7 apr 2020 but today s endless wars truly
